



## Application for I-20 International Undergraduate Applicants

### Instructions

This form is to be completed and submitted along with the required application materials to issue an I-20 Certificate of Eligibility document to be used to apply for the student F-1 visa. You are required to submit evidence of adequate readily available funding for at least one year of the estimated tuition/fees and living expenses. Your undergraduate application will not be considered complete until this I-20 application and financial documentation is received.

In addition, accepted students must submit their enrollment confirmation and tuition deposit at [www.ocac.edu/reservemyspot](http://www.ocac.edu/reservemyspot) before an I-20 Certificate of Eligibility document can be issued.

Return this completed and signed I-20 Application along with all required materials in English and in USA dollars. **Materials to submit:**

- Proof of finances via original bank statement or letter dated within the last three months along with a translation into English and conversion into US dollars
- Certification from sponsor of financial support and proof of their finances (originals and translations)
- Copy of biographical page of your passport
- Copy of expiration date on your passport
- Copy of all USA visa stamps from your passport, if any
- If coming with dependents: list and provide copies of passports and certificates
- Transfer information sheet if currently on a valid F-1 from a US institution--include a copy of your current I-20

You are required to certify that you have sufficient funds available for your academic and living expenses. The following expense amounts are the minimum funds needed for one year. Please complete the chart on page two of this form with these amounts in mind. These are projected 2017-2018 costs; tuition and other expenses can be expected to increase 3-10% yearly.

\*Health Insurance is required of all students. Students who provide proof of their own health insurance coverage that covers them while in the United States may have this fee waived. Otherwise students are automatically billed for health insurance and it is provided when the academic term begins.

Summer Expenses will require approximately \$3,400 in addition to the above, plus any excess summer tuition and fees.

Family Expenses: If you are married and plan to bring your spouse and/or children, you must also certify and provide proof of at least \$11,000/year for your spouse and \$4,000/year for each child.
